With reference to UGC, New Delhi Letter No. F-1-7/2011 (SCT), dt:26-06-2019, we would like to bring to your kind knowledge that, as per the directions from University Grants Commission-New Delhi, as well as our Institution's policy, we have developed a page on our college official website (www.kittiptur.ac.in) for lodging any complaints by SC/ST students with regard to Caste Discrimination. We have also taken measures to maintain a Complaint Register in the Principal's office for the aforementioned purpose. We also would like to inform you that we have constituted a committee comprising senior members as shown under to look into the discriminating complaints, if any, received from the SCs/STs/OBC students/Teachers and Non teaching staffs.

Further, we have firmly advised all the concerned faculty members of our institute to exercise utmost caution and exhibit sensitivity while dealing with such incidents of Caste Discrimination. Such complaints should be dealt with immediately and proper actions should be initiated. All the students of our institute have been duly notified to lodge a complaint on the Institute's official website and contact any of the following committee members immediately in case of any emergencies related to caste based discrimination.

We would like to state that, no complaints of Caste Discrimination whatsoever have been received from any of our students during the academic year- 2018-19.
